

**RESOLUTION NO. 180**

**2026**

**A RESOLUTION OF THE CITY OF EAST HOPE, A MUNICIPAL CORPORATION OF IDAHO,  
ADOPTING A FEE SCHEDULE**

WHEREAS, the City Council deems it advisable to adopt existing fees set by earlier resolutions in one general fee resolution; and

WHEREAS, the City of East Hope has the authority pursuant to East Hope City Code and Idaho Code §63-1311 to collect fees for services provided by the City that would otherwise be funded by property tax revenue, and such fees shall be reasonably related to, but shall not exceed, the actual cost of the services rendered; and

WHEREAS, pursuant to Idaho Code § 63-1311A, proposed new City fees or fee increases in excess of five percent (5%) require a public hearing prior to approval; and

WHEREAS, a notice listing such fees and the date and time of the public hearing was published in the Bonner County Daily Bee, the City's newspaper of record, on DATES; February 27, 2026 and March 6, 2026 and

WHEREAS, the City of East Hope conducted a public hearing on March 10, 2026, to consider new fees and fee increases in excess of 5%, and to take public testimony regarding the proposed fee schedule; and

WHEREAS, the City of East Hope annually reviews all fees during the budget process to ensure accuracy; and

WHEREAS, periodic revisions to fees may be necessary; and

WHEREAS, the City of East Hope has determined that the fee schedule should be amended to reflect the reasonable cost of providing services; and

WHEREAS, the East Hope City Council deems the fee adjustments are in compliance with the requirements of Idaho Code §63-1311 and 63-1131A and are in the best interests of the City of East Hope and its citizens.

NOW, THEREFOR, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF EAST HOPE THAT:

Section 1. The East Hope Fee Schedule (attached pages, exhibit "A" ), containing 1 table, and dated March 10, 2026 is hereby adopted and declared effective upon adoption.

Section 2. City staff is directed to take all administrative actions necessary to implement the attached listing of effective City fees.

Section 3. Any fee inconsistent with the provisions of this Resolution is hereby repealed or superseded to the extent of such inconsistency, as appropriate.
